## U.S. COMMISSIONER TO ATTEND JANUARY 19 CITIZENS FORUM FOR THE COLORADO RIVER; PROGRESS OF THE NEW RIVER IMPROVEMENT PLAN AND U.S.-MEXICO COLORADO RIVER COOPERATION ON AGENDA

Commissioner Maria-Elena Giner, head of the United States Section of the International Boundary and Water Commission (USIBWC) will attend the Colorado River Citizens Forum on **Wednesday, January 19, 4:00-6:00 p.m. MST/3:00 – 5:00 p.m. PST via Teams webinar**. The New River Improvement Project and U.S.-Mexico Colorado River cooperation will be the focus of the meeting, which is open to the public. The Colorado River Citizens Forum was established to facilitate the exchange of information with the public about Commission activities and related matters.

An update on the New River Improvement Project Calexico Reach will be provided by Program Manager Jose L. Angel, P.E., City of Calexico. The Project has three main components: a Trash Screen and Diversion Structure for the New River downstream from the international boundary; a 72-inch underground bypass pipe to divert up to 160 cubic feet per second of the polluted flow from Mexico from a point about 800 feet downstream from the border to a point about 300 feet upstream of where the river crosses the All-American Canal Siphon; and a pumpback system to discharge treated, disinfected wastewater from the City of Calexico Wastewater Treatment Plant immediately downstream of the diversion structure. Mr. Angel will provide an overview of these Project components, Project permitting status, and draft construction schedule.

In other business, USIBWC Secretary Sally Spener will give a presentation on Minute No. 323, a comprehensive Commission agreement related to U.S.-Mexico cooperation on the Colorado River. The Minute covers development of water conservation projects, environmental restoration, and drought management, among other topics. Ms. Spener will provide an update on implementation of the Minute, including how the United States and Mexico are cooperating in light of the first declared shortage on the Colorado River.
